Cash Gifts

YWCA St. Paul accepts gifts by cash, check and credit card. You may elect to make a one-time gift, be billed on a regular schedule, or have the donation automatically deducted from your checking or savings account.

Online Donations - Online donations are processed through Network for Good. To donate online, visit www.ywcaofstpaul.org, then click donate. Your gift will be processed instantly via a secure online connection.

Recurring Gifts - Flexible options allow you to divide your gift into monthly, quarterly or annual installments.

Electronic Funds Transfer - Giving made easier! Your designated gift is deducted monthly from your checking or savings account. Simple to start, change or stop, EFT eliminates monthly check writing and saves time, postage and banking fees.
